Conditions of Enrollment 2021

CANCELLATION

All cancellations must be made in writing. The following fees will apply based on the date written cancellation is postmarked:

The \$250 registration fee is non-refundable at any time for any reason.

Cancellation Fee (in addition to the non-refundable registration fee):

- No charge for cancellations before May 1
- After May 1 there is a \$500.00 cancellation charge
- After June 1, there are no refunds

Exceptions will be made for campers suffering from illness or injury who submit a doctor's letter stating that the illness or injury prevents safe participation in camp. In this case, credit for future sessions will be issued.

We recommend the purchase of trip and travel insurance to protect your investment in your child's summer camp experience.

WITHDRAWAL

It is understood that Catalina Island Camps has a limited enrollment in each session with fixed and consistent operating costs. Because of these limitations, no refund or reduction for tuition will be made for the withdrawal of a camper, his/her late arrival or early departure.

ILLNESS

Should a camper become ill or injured during his/her stay and be required by the directors to return home, then at the sole discretion of the camp administration, the parent/guardian shall receive up to one-half (1/2) of the remaining tuition in the form of a credit on account or a cash refund.

DISMISSAL

Catalina Island Camps reserves the right to dismiss a camper whose conduct or influence is unsatisfactory or, in the opinion of the directors, not in the best interest of the camp. In the event of such a dismissal, no refund or credit will be made. Possession of or use of tobacco, alcohol, illegal drugs or possession of any weapon or threat of the use of a weapon is grounds for immediate dismissal from camp.

AIRPORT TRANSPORTATION

Due to COVID-19, Catalina Island Camps requires all campers to be accompanied by a parent or guardian to check in at the start of any session. Therefore, we cannot provide any airport service this summer.

HEALTH

Catalina Island Camps requires that all campers have a physical exam within 12 months of attending camp. The health history is collected online in the spring. We will contact you with more information at that time. The Doctors Form will be provided. A new Doctors Form is required each year. This form must be completed and signed by both the child's parent/guardian and physician. It is understood that, unless otherwise

indicated, your child is in good health and may actively participate in all camp activities. This form must be returned to the camp office by May 1.

ACTIVITIES

Vigorous outdoor and recreational activities are integral parts of the camp program. Any physical activity has hazards, but the camp administration believes that with supervision and instruction, the benefits outweigh hazards. The camp establishes minimum standards of participation for each activity. No camper is forced to participate; however, all campers are expected to meet the minimum standard at each activity. If you have any questions or need more information about any of these programs, please contact our office.

EMERGENCY INFORMATION

We rely on this completed enrollment application for your child's safety and well-being. If any of the information about your child should change, please notify the camp immediately in writing. In the event that a parent/guardian is traveling during a camp session, the camp will need an alternate emergency contact that will be available during the camp session.

If my child is accepted for enrollment, I agree that:

1. Catalina Island Camps cannot be responsible for any injury that is not the fault of Catalina Island Camps beyond the assurance the injury will receive professional care.
2. If my child requires medical attention, Catalina Island Camps has my authorization to obtain it from any licensed physician or hospital as the camp deems necessary and Catalina Island Camps may act in my place in this regard. This authorization applies whether my personal insurance or camper insurance covers damages.
3. I agree to pay tuition and fees for my registered child(ren). C
4. Catalina Island Camps may use my child's image/video in camp any promotional material or social media.
