CATALINA ISLAND CAMPS

Conditions of Enrollment

CANCELLATION: All cancellations must be made in writing and submitted to info@catalinaislandcamps.com or delivered to 707 W. Woodbury Rd, Ste. F, Altadena CA 91001. The following fees will apply based on the date written cancellation is postmarked and/or delivered, whichever is earlier: The \$250 registration fee is non-refundable at any time for any reason.

Cancellation Fee (in addition to the non-refundable registration fee):

- No additional charge for cancellations by May 1
- After May 1 there is a \$500.00 cancellation charge
- After June 1, there are no refunds.

Exceptions will be made for campers suffering from illness or injury who submit a doctor's letter stating that the illness or injury prevents safe participation in camp. In this case, credit for a future session will be issued. However, no refund or credit will be issued if the camper cannot attend camp due to a positive COVID-19 test result. We highly recommend the purchase of trip and travel insurance for protection of financial investment. Travel insurance information will be included with confirmation paperwork.

WITHDRAWAL: It is understood that Catalina Island Camps has a limited enrollment in each session with fixed and consistent operating costs. Because of these limitations, no refund or reduction for tuition will be made for the withdrawal of a camper, his/her late arrival or early departure.

ILLNESS: If a camper becomes ill or injured during his/her stay, at the sole discretion of the camp administration, the camper may be required to return home. Any potential refund i at the sole discretion of the camp administration but in no event will a refund exceed one-half (½) of the paid tuition. Any refund will be in the form of a credit on account for a future session or a cash refund.

DISMISSAL: Catalina Island Camps reserves the right to dismiss a camper whose conduct or influence is unsatisfactory or, in the opinion of the directors, not in the best interest of the camp. In the event of such a dismissal, no refund or credit will be made. Possession of tobacco, vape products, alcohol, illegal drugs, drug paraphernalia, or weapons is grounds for immediate dismissal from camp.

HEALTH: Catalina Island Camps requires that all campers have a physical exam within 12 months of attending camp. A new form is required each year and will be sent with confirmation of enrollment. It is understood that, unless otherwise indicated, your child is in good health and may actively participate in all camp activities. This form must be returned to the camp office by May 1. In addition, a health history is collected online in the spring.

COVID-19: Catalina Island Campers will be required to abide by any CDC, federal, county, state and local regulations and recommendations concerning COVID-19 as well as any policies and requirements that Catalina Island Camps may adopt and/or implement. Further information will be provided later. Parents and/or guardians will be required to sign and return a COVID-19 Warning & Disclaimer before participating.

ACTIVITIES: Vigorous outdoor and recreational activities are integral parts of the camp program. Any physical activity has hazards, but the camp administration believes that with supervision and instruction, the benefits outweigh hazards. The camp establishes minimum levels of participation for each activity. No camper is forced to participate; however, all campers are expected to meet the minimum level at each activity. If you have any questions or need more information about any of these programs, please contact our office.

EMERGENCY INFORMATION: We rely on this completed enrollment application for your child's safety and well-being. It is vitally important that all the emergency and medical information is accurate and up to date before the camper attends

camp. If any of the information about your child should change, please notify the camp immediately in writing. If a parent/guardian is traveling during a camp session, the camp will need an alternate emergency contact that will be available during the camp session.

If my child is accepted for enrollment, I agree that:

- 1. I agree to complete all required documents from Catalina Island Camps including Waiver of Liability, and agree to be bound to the terms set forth therein.
- 2. Catalina Island Camps will not be responsible or liable for any injuries or damages caused by a third-party. Regardless of cause, Catalina Island Camps will provide professional care and medical attention.
- 3. . If my child requires medical attention, Catalina Island Camps has my authorization to obtain it from any licensed physician, hospital or urgent care as the camp deems necessary and Catalina Island Camps may act in my place in this regard. This authorization applies whether my personal insurance or camper insurance covers damages. This authorization does not mean or intend to make Catalina Island Camps legally or financially responsible or liable for the costs of any medical treatment that my child may require. This includes any emergency and/or medical transportation that may be required or necessary for the treatment of my child as determined by CIC or licensed physician, or nurse.
- 4. I agree to pay all tuition and fees for my registered child(ren) in a timely fashion.
- 5. I consent for Catalina Island Camps to use my child's image, photograph, likeness or video recording during his/her attendance at camp for any promotional material or social media.
